NOTIFICATION

No.P&D/RO(Prog)/Gen/2016/6732 With prior approval of the competent authority and in supersession of this department's notification No. P&D/RO(Prog)/Gen/2008/5458 dated 25th November, 2008 the Government of Balochistan, Planning & Development Department, is pleased to enhance the financial powers of the Departmental Sub Committee (DSC) from Rs. 10.00 M (rupees ten million) to Rs. 100.00 M (rupees hundred million) for approval of development schemes with immediate effect and till further orders. The development schemes beyond the enhanced limit would be processed by the Provincial Development Working Party (PDWP).

2. Composition of the DSC, its mandate, and terms and conditions shall be the same as mentioned in the Government of Balochistan Secretariat Instructions 2013.
3. DSC shall not have the powers of re-appropriation, revision and authorization.
4. DSC shall not approve federal government/ foreign aided projects.


