  - b. Financial capacity of firm must exceed with a turnover of PKR 15 Million in last three years,
  - c. Registration with relevant taxation departments,
  - d. Submit a self-declaration for not being under legal action for corrupt or fraudulent practices (blacklisted) by any Government Organization.
3. **Method of Procurement:-** Single Stage – Two Envelop Procedure
4. **Method of Evaluation: -** Quality-and-Cost-Based Selection (QCBS)
