In continuation of this Department Notification No.SO(Legal)3-12/2017/1845-1860, dated 20th April, 2017 and approval conveyed by Service & General Administration Department Government of Balochistan vide No.8-1 (11)2016/SO-I(S&GAD) Dated 15th June, 2017, the following terms and conditions for appointment of Mr. Amir Zaman Jogezeai, Prosecutor General (B-20) on contract basis w.e.f. 20th April, 2017 is hereby notified:-

| 1. | Pay | He will be entitled to draw the minimum of pay scale (B-20) |
| 2. | Allowances | He will be entitled to draw allowances of corresponding class admissible from time to time. |
| 3. | Non-Practicing allowance | Rs. 200,000/- per month |
| 4. | Transport | One 1300cc with 300 liters petrol per month. |
| 5. | TA/DA | Travel by air in economy class and a daily allowance of Rs. 2025/- per day as admissible under the rules subject to the prior approval of his tour programme and sanction of TA/DA bill from the Administrative Secretary. |
| 6. | Pension and provident fund | He will not be entitled to any pension for the period of contract appointment and will not be entitled to subscribe to the provident fund during this period. |
| 7. | Medical facilities | He will be entitled to same medical facilities as admissible to (B-20) Officer under the rules. |
| 8. | Leave | He will be allowed to avail leave in accordance with Rules applicable to contract employees subject to the prior approval from the Administrative Secretary. |
| 9. | Government conduct Rules | Servant He will be subject to conduct rules etc as provided in the Balochistan Government Servant (conduct) Rules 1979. He will not have a direct correspondence with any line department directly, but through his Administrative Secretary and if found, it will be treated as misconduct. |
| 10. | Job Description | It will be a full time job and he will not be allowed to do any private job. Its violation, if found or reported any liable him to cancel his contract without assigning any reasons thereof. |
| 11. | Period of contract | One year with effect from date of issuance of notification. |
| 12. | Termination of Contract | Being temporary and contract employee, his services will be liable to termination on one month notice from either side on any ground in lieu of one month's pay will be paid/deposited. The Government however reserves the right to terminate his services at any time if it is found on medical evidence that he is unfit or is luckily to remain unfit for the discharge of his duties or if found guilty of insubordination, intemperance, misconduct or any breach of these terms and conditions or any rules pertaining to his service, or failed to perform his duty satisfactorily and in violation of the provision of the prevailing, Act 2003 and rules thereof. The decision of the Government in this matter shall be conclusive and binding on him which may not be challenged in any court of Law by him or his relatives or any body else. |
