## THE BALOCHISTAN LAWS REGULATION, 1913

(Baln Reg. II of 1913)

[18th August, 1913]

A Regulation to consolidate and amend the Regulations declaring the Law in force in <sup>1</sup>[\* \* \*] Balochistan.

WHEREAS it is expedient to consolidate and amend the Regulations declaring the Law in force in <sup>1</sup>[\* \* \*] Balochistan; It is hereby enacted as follows:-

Short title and commencemen t.

- 1. (1) This Regulation may be called the <sup>1</sup>[\* \* \*] Balochistan Laws Regulation, 1913, and
  - (2) It shall come into force at once.

Division of <sup>2</sup>[\*\*\*] Balochistan into districts and tehsils. 2. The <sup>2</sup>[Provincial Government], <sup>3</sup>[\* \* \* \*] may, for administrative purpose, divided <sup>1</sup>[\* \* \*] Balochistan into districts, and each of those districts into tehsils, and vary the limits of those districts into tehsils.

- 3. (1) So much of each of the enactments specified in Schedule I as is in force in the territories to which the enactment generally applies shall be deemed to be in force in <sup>1</sup>[\* \* \*] Balochistan or in the part thereof specified in the Schedule, subject to the modifications therein stated, and to any amendments <sup>4</sup>[made on or before the 1<sup>st</sup> day of April, 1937], to which the enactments are for the time being subject in the territories to which they generally apply.
- (2) An enactment <sup>5</sup>[enacted prior to the 1<sup>st</sup> day of April, 1937 and] not comprised in Schedule I shall not be deemed to be, or to have been in force in Balochistan or in any part of <sup>1</sup>[\* \* \*] Balochistan unless it is expressed, by special mention of <sup>6</sup>[\* \* \*] Balochistan or a part of <sup>1</sup>[\* \* \*] Balochistan, to extend thereto, or, 3 after the commencement of this Regulation, is extended <sup>7</sup>thereto in exercises of the powers conferred by section 5 of the Scheduled Districts Act, 1874<sup>8</sup> or

by any other enactment for the time being in force.

- \* may, by notification in the <sup>3</sup>[Official Gazette] declare that any enactment which is comprised in Schedule I or which may after the commencement of this Regulation, be extended in exercise of any such powers as aforesaid, shall not longer be in force in <sup>1</sup>[\* \* \*] Balochistan or in any part of <sup>1</sup>[\* \* \*] Balochistan specified in the notification.
- <sup>4</sup>[3-A. (1) When in any suit it is necessary for Court to decide any question regarding succession, inheritance, preemption, marriage or caste, or any religious usage or institution, the Muhammadan Law, in cases where the parties are Muhammadans, and the Hindu Law, in cases where the parties are Hindus, shall form the rule of decision, except in so far as that law has been altered or abolished by legislative enactment or is opposed to any custom having the force of law in <sup>1</sup>[\* \* \*] Balochistan.
- (2) In cases not provided for by sub-section (1) or by any law for the time being in force, the Court shall act according to justice, equity and good conscience.]

- 4. The provision of the <sup>5</sup>[\* \* \* Stamp Act, 1898,] with respect to the consequences of instruments not being duly stamped, shall be read as not applying to any instrument which may have been executed in <sup>1</sup>[\* \* \*] Balochistan before the 19<sup>th</sup> April, 1890.
- Construction of enactments.
- of 5. (1) For the purpose of facilitating the application of any enactment for the time being in force in <sup>6</sup>[\* \* \*] Balochistan, a Court may construe the enactment with such alterations not affecting the substance as may be necessary or proper to adopt it to the matter before the Court.

behalf by order of the Judicial Commissioner may allow any police officer to conduct a prosecution.

(5) The power conferred by clause (c) of sub-section (2) of section 554 shall include a power to make rules regulating the qualifications to be possessed by, and the conditions to be imposed on, legal practitioners applying for authority to practice Criminal in Courts, and the fees, if any, to be paid for the concession of such authority, and for determining the authority by which breaches of such rules shall be investigated, and the penalties which may be imposed".

The word 'land' in this subsection means land which is not occupied as the site of any building in a town or village and is occupied or has been let for agricultural purposes or for purposes subservient to agriculture, or for pasture, and includes the sites of buildings other structures on such land.

- (3) Sections 100, 101, 102, and 103 shall be omitted.
  - (i) the Provincial Government, and
  - (ii) the official Gazette shall be respectively construes as references to—
    - (i) the Chief Commissioner of <sup>4</sup>[\*]Balochistan, and

District Magistrate or to the Chief Judge of the Small Cause Court, in the case of decision by the Commissioner of Police" and the words "or Chief Judge of the Small Cause Court, as the case may be" shall be omitted;
