A Regulation to provide for the extension of the West Pakistan Civil Courts Ordinance, 1962<sup>1</sup>, to the Tribal Areas of Quetta Division.

Preamble.

WHEREAS clause (2) of Article 223 of the Constitution of the Republic of Pakistan provides that the Governor of West Pakistan with the approval of the President may, with respect to any matter within the legislative competence of the Provincial Legislature, make regulations for a Tribal Area or any part of a Tribal Area situated in the Province;

AND WHEREAS it is expedient to provide for the extension of the West Pakistan Civil Courts Ordinance, 1962, to the <sup>2</sup>Tribal Areas of Quetta Division;

NOW, THEREFORE, the Governor of West Pakistan, with the approval of the President, is pleased to make the following Regulations:—

Short title and commencement.

1. (1) This Regulation may be called the West Pakistan Civil Courts Ordinance (Extension to <sup>2</sup>Tribal Areas of Quetta Division) Regulation, 1963.

(2) It extends to the <sup>2</sup>Tribal Areas forming part of Quetta Division.

West Pakistan Ordinance II of 1962.

2. The West Pakistan Civil Courts Ordinance, 1962, as in force from time to time, shall apply to the <sup>2</sup>Tribal Areas of Quetta Division.
