In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Coastal Development and Fisheries Department (BPS-16 and above) Service Rules, 2016 (Service Rules No. XVI of 2016), namely: -

In the aforesaid rules, in Appendix (Part-A Technical Wing),-

- (a) against Serial No. 1, for the existing entries, the following shall be substituted, namely,-

1.	Director Fisheries, General (BPS-20).	---	<p>By promotion from amongst the members of the Service holding the posts of Director Fisheries (Marine) (BPS-19), Director Fisheries (Inland) (BPS-19), Director Fisheries (Dams) (BPS-19) and Director Fisheries (Planning) (BPS-19), having seventeen (17) years' service in BPS-17 and above including at least two (2) years' Service as such; and have successfully completed Senior Management Course, on seniority cum fitness basis;</p> <p>Provided that for the purpose of promotion a combined seniority list shall be maintained from the date of their regular promotion in that cadre, post and Basic Pay Scale;</p> <p>OR</p> <p>If no suitable officer is available then by transfer from amongst BCS / BSS officers of equivalent grade.</p>
