In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Board of Revenue Officers (BPS-16 and above) Service Rules, 2017 (*Service Rules No. XVI of 2017*), namely:-

- (a) for the entries against Serial No. 7, the following shall be substituted, namely,-

7.	Private Secretary, (BPS-17).	---	By promotion from amongst the members of the Service holding the post of Assistant Private Secretary (BPS-16), of Board of Revenue having at least three (3) years service as such, on seniority cum fitness basis.

(b) after Serial No. 7 as so amended, the following new entries shall be inserted, namely,-

Assistant Chief Inspector, (BPS-17)	---	By promotion from amongst the members of the Service holding the post of Senior Stamp Inspector (BPS-16) having at least five (5) years service as such on seniority cum fitness basis. In case of non-availability of such an officer, the post shall be filled by trained postholders of the officers in the grade made from BPS-16.

10	Assistant, (BPS-16).	<p>(a) Bachelor's Degree from a recognized University; and</p> <p>(b) having at least three months Office Automation Certificate in computer operations from a recognized Institute.</p>	<p>(a) 60% by promotion from amongst the members of the Subordinate Service holding the post of Senior Clerk (BPS-14), of Board of Revenue having at least three (3) years service as such, on seniority cum fitness basis; and</p> <p>(b) 40% by initial recruitment.</p>

12.	Assistant Legal Officer (BPS-16)	Bachelor's Degree in Law (LL.B) at least in Second Division from a recognized University.	By initial recruitment.
