NOTIFICATION

No.SOR-II (12)22/2021-S&GAD/ 669-82. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Directorate of Tourism Balochistan (BPS-1 to 15) Service Rules, 2018 (*Service Rules No. IX of 2018*), namely:-

In the aforesaid rules, in Appendix,-

(a) against S.No. 1, 6 and 7, for the existing entries, the following shall be substituted, namely,-

1.	Inspector, (BPS-14).	Bachelor's Degree at least in Second Division from a recognized University.	(a) 50% by promotion from amongst the members of the Service holding the post of Sub-Inspector (BPS-11) having at least five (5) years' service as such, on seniority cum fitness basis; and having fourteen years' educational qualification. The condition of fourteen years' educational qualification for promotion is relaxed on attaining the age of 55 years; and (b) 50% by initial recruitment.
6.	Sub-Inspector, (BPS-11).	Bachelor's Degree at least in Second Division from a recognized University.	(a) 25% by promotion from amongst the members of the Service holding the post of Constable (BPS-7) possessing Higher Secondary School Certificate with at least seven (7) years' service as such, on seniority cum fitness basis; and (b) 75% by initial recruitment.



7.	Tourist Guide, (BPS-11).	Bachelor's Degree at least in Second Division from a recognized University.	(a) 25% by promotion from amongst the members of the Service holding the post of Unit Manager (BPS-7) having at least seven (7) years' service as such, on seniority cum fitness basis; and (b) 75% by initial recruitment.

(b) after S.No. 10, the following new entries shall be inserted, namely,-

10-A.	Receptionist, (BPS-5).	Secondary School Certificate from a recognized Board.	By initial recruitment.
10-B.	Diver, (BPS-4).	(a) Secondary School Certificate from a recognized Board; and (b) expert in swimming.	By initial recruitment. Diver Course will be mandatory and will be imparted by a Government recognized Institute during the probationary period after appointment.

(c) after S.No. 15, the following new entries shall be inserted, namely,-

16.	Waiter, (BPS-1).	Literate.	By initial recruitment.
17.	Chowkidar, (BPS-1).	Literate.	By initial recruitment.
18.	Sweeper, (BPS-1).	Literate.	By initial recruitment.
