No.SOR-II(12)21/2020-S&GAD/ 2901-50. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Directorate of Archaeology and Museums Balochistan (BPS-16 and above) Service Rules, 2017 (Service Rules No. XLVII of 2017), namely: -

In the aforesaid rules, in Appendix

- (a) against Serial No. 3, 4, 6, 7 and 8, for the existing entries, the following shall be substituted, namely,-

6.	Assistant Director Archaeology and Museums, (BPS-17).	Master's Degree at least in Second Division in Archaeology from a recognized University.	(a) 50% by promotion from amongst the members of the Service holding the post of Senior Supervisor/ Field Officer/ Assistant Curator (BPS-16) having at least three (3) years' service as such, on seniority cum fitness basis; and

			(b) 50% by initial recruitment.

Accounts Officer, (BPS-17).	<p>(a) Master's Degree (at least in Second Division) in Commerce from a recognized University; or</p> <p>(b) Degree in Chartered Accountancy (CA) from a recognized Institute of Chartered Accounts of Pakistan; or</p> <p>(c) Degree in Cost and Management Accounting (CMA) from a recognized Institute of Cost and Management Accounts of Pakistan; or</p> <p>(d) ACCA qualification from a recognized Association of Chartered Certified Accountants/ Institute; or</p> <p>(e) Bachelor's Degree (at least in Second Division) in Business Administration from a recognized University.</p>	<p>(a) 50% by promotion from amongst the members of the Service holding the post of Accounts Assistant (BPS-14) having at least three (3) years' service as such, on seniority cum fitness basis; and</p> <p>(b) 50% by initial recruitment.</p>
8.	Administrative Officer, (BPS-17).	---	By promotion from amongst the members of the Service holding the post of Superintendent (BPS-17) having at least three (3) years' service as such, on seniority cum fitness basis.

8-A.	Archaeologist (Field Officer), (BPS-17).	Master's Degree or equivalent degree at least in Second Division in Archaeology from a recognized University.	By initial recruitment.
8-B.	Museum Guide, (BPS-17).	Master's Degree or equivalent degree at least in Second Division in Archaeology from a recognized University.	By initial recruitment.

(d) against Serial No. 12, 13 and 14, for the existing entries, the following shall be substituted, namely,-

12.	Conservator, (BPS-16).	(a) Three (3) years' Diploma of Associate Engineering in Civil Technology from a recognized Institute/ University; or (b) Bachelor of Engineering in Civil Technology from a recognized University.	(a) 25% by promotion from amongst the members of the Subordinate Service holding the post of Senior Photographer (BPS-14) having three (3) years Diploma in Civil Engineering from recognized Institute with at least three (3) years' service as such, on seniority cum fitness basis; and (b) 75% by initial recruitment.
13.	Field Supervisor, (BPS-16).	Master's Degree at least in Second Division in Archaeology from a recognized University.	(a) 50% by promotion from amongst the members of the Subordinate Service holding the post of Surveyor (BPS-11) having at least three (3) years' service as such, on seniority cum fitness basis; and (b) 50% by initial recruitment.



14.	Draws Man, (BPS-16).	(a) Master's Degree at least in Second Division in Archaeology from a recognized University; and (b) having experience in Antiquities Drawings.	By initial recruitment.
