NOTIFICATION

No.SOR-II (4)21/2021-S&GAD/3246-94. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Secondary Education Department (School Branch) (Men's Section) (BPS-16 and above) Service Rules, 2020 (Service Rules No. XIII of 2020), namely:-

In the aforesaid rules, in Appendix,-

(a) against Serial No. 9, for the existing entries the following shall be substituted, namely,-

9.	Headmaster, (BPS-17).	(a) Master's Degree with B.Ed. at least in Second Division from a recognized University; or (b) BS in Science (4-years) from a recognized University; or (c) Bachelor's Degree in Information Technology (4-years) from a recognized University.	(a) 75% by promotion from amongst the members of the Service holding the mentioned below posts with at least three (3) years' Service in BPS-17 on seniority-cum-fitness basis, on the following ratio:- (i) 69% by SST (Science) (BPS-17), SST (General) (BPS-17) and SST (Tech:) (BPS-17); provided that for the purpose of promotion a combined seniority list shall be maintained from the date of their regular promotion or appointment in that cadre, post and Basic Pay Scale; (ii) 2% by Senior Physical Education Teacher (BPS-17); (iii) 2% by Senior Drawing Master (BPS-17); and (iv) 2% by Senior Arabic Teacher (BPS-17); and (b) 25% by initial recruitment.

(a) Subject Specialist, (BPS-17); and	(a) Master's Degree with B.Ed. at least in Second Division from a recognized University; or	(a) 75% by promotion from amongst the members of the Service holding the post of SST (Science) (BPS-17), SST (General) (BPS-17) and SST (Tech) (BPS-17) having at least three (3) years' Service in BPS-17 on seniority-cum-fitness basis; provided that for the purpose of promotion a combined seniority list shall be maintained from the date of their regular promotion or appointment in that cadre, post and Basic Pay Scale ; and
	(b) Assistant Director; (BPS-17).	(b) BS in Science (4-years) from a recognized University; or	
		(c) Bachelor's Degree in Information Technology (4-years) from a recognized University.	(b) 25% by initial recruitment.
