No.SOR-II (12)13/2017-S&GAD/1879-1920 In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Provincial Library Balochistan (BPS-16 and above) Service Rules, 2017 (Service Rules No. XLIX of 2017), namely:-

In the aforesaid rules, in Appendix,—

- (a) the existing S.No.1 shall be renumbered as 1-A, and at S.No.1, the following new entry shall be inserted, namely,—

Computer Science or BCS (4 years) from a recognized University with at least three (3) years' service as such, on seniority cum fitness basis; and</p> <p>(b) 50% by initial recruitment.</p>

Assistant Librarian, (BPS-16).	<p>(a) Bachelor's Degree at least in second division from a recognized University; and</p> <p>(b) Diploma in Library Science/ Library Information Science from a recognized University.</p>	<p>(a) 50% by promotion from amongst the members of the Service holding the post of Assistant Cataloguer (BPS-14) and Assistant Classifier (BPS-14) (on combined seniority) having at least three (3) years' service as such, on seniority cum fitness basis; with Graduation or equivalent qualification in relevant subject. The condition of Graduation/ equivalent qualification for promotion is relaxed on attaining the age of 55 years; and</p> <p>(b) 50% by initial recruitment.</p>
