In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Sports and Youth Affairs Department (Directorate of Sports) (BPS-16 and above) Service Rules, 2016 (Service Rules No. VIII of 2016), namely: -

In the aforesaid rules, in Appendix, against Serial No. 3, 4, 5 and 10, for the existing entries, the following shall be substituted, namely,-

Deputy Director Sports, (BPS-18).	---	<p>By promotion from amongst the members of the Service holding the posts of Assistant Director Sports (BPS-17), District Sports Officer (BPS-17) and Assistant Director (Admn) (BPS-17) having at least five (5) years service, on seniority cum fitness basis;</p> <p>provided that for the purpose of promotion a combined seniority list shall be maintained from the date of their appointment or regular promotion in that cadre, post and grade.</p>

Assistant Director Sports, (BPS-17).	<p>(a) Master's Degree at least in (Second Division) in Physical Education from a recognized University; and</p> <p>(b) Certificate of 1st or 2nd position in any individual National Sports Events (National Games/National Championships of recognized games) or participated in teams as National Player.</p>	<p>(a) 50% by promotion from amongst the members of the Service holding the post of Supervisor (BPS-14) having at least five (5) years service as such, on seniority cum fitness basis; and</p> <p>(b) 50% by initial recruitment.</p>

5.	Assistant Director (Admn), (BPS-17).	(a) Master's Degree at least in (Second Division) in Public Administration from a recognized University; or (b) Bachelor's Degree at least in (Second Division) in Business Administration or equivalent qualification from a recognized University.	(a) 75% by promotion from amongst the members of the Service holding the post of Superintendent (BPS-17) having at least three (3) years service as such, on seniority cum fitness basis; and (b) 25% by initial recruitment.
10.	District Sports Officer, (BPS-17).	(a) M.Sc. in Physical Education from a recognized Institute; and (b) At least 3 years' experience in office Management/ Administration.	(a) 50% by promotion from amongst the members of the Subordinate Service holding the post of Supervisor (BPS-14) having at least five (5) years' service as such, on seniority cum fitness basis; and (b) 50% by initial recruitment.
