**NOTIFICATION**

[11<sup>th</sup> November, 1979]

No. ALR- 372/12685/ In exercise of the powers conferred by Section 7 of the Balochistan Students Welfare Fund Ordinance, 1979<sup>3</sup> (II of 1979), the Government of Balochistan is pleased to make the following rules namely:—

1. **Short title and commencement.**— (1) These rules may be called the Balochistan Students Welfare Fund Rules, 1979.

(2) They shall come into force at once.

2. **Raising of Funds.**— The funds may be raised in all or any of the following manners.

a. Voluntary donations/ gifts by the public.

b. Grant-in-aid by the Government.

c. Sale of flags/seals.

d. Holding of Meena Bazars, Variety shows and sports tournaments etc.

3. **Meetings of the Board.**— (1) The meetings of the Board shall be held at least once in three months.

(2) A meeting of the Board may be called by the Chairman whenever considered necessary.

(3) The Chairman and two members, at least one of whom should be a non-official member, shall form quorum for any meeting of the Board.

(4) Decisions of the Board shall be taken by Majority of votes. In case of equality of votes the Chairman shall have a second or casting vote.

(5) All decisions of the Board shall be recorded to the minutes book. The duty of recording of minutes shall be discharged by the Secretary of the Board and in his absence by another member of the Board as directed by the Chairman.

(6) Subject to general supervision and control of the Chairman, the Secretary shall be responsible for:—

(i) the conduct of correspondence on behalf of the board;

- (ii) the maintenance of records of the Board;
- (iii) the operation of the funds;
- (iv) maintenance of accounts;
- (v) preparation of the agenda of the meeting of the Board and giving advance notice of such meetings to the members of the Board;
- (vi) performance of such other functions as may be directed by the Chairman.

4. **Remuneration.**— Members of the Board shall not be entitled to any remuneration.

5. **Disposal of Business.**— The Board may invest such money constituting the fund as are not required for immediate expenditure in any of the securities described in Section 20 of the Trust Act 1882<sup>1</sup>, or may place there in fixed deposit with any scheduled Bank at Quetta.

6. **Drawals.**— Any amount authorised by the Board to be disbursed shall be drawn from the Bank through a cheque signed by the Chairman:

Provided that the Chairman, with the prior approval of the Board, may authorise the Secretary of the Board to sign cheques on his behalf subject to such conditions as may be prescribed.

7. **Account.**— The accounts shall be kept by the Board in Form-I and II annexed hereto.

8. **Grants.**— (1) The Board may sanction grants to the students as it may deem necessary for the following purposes:—

- (a) financial assistance in distress particularly for medical treatment,
- (b) to encourage and subsidize sports amongst the students either by themselves or through Sports Associations/ Sports Committees for conducting sports activities for students,
- (c) financial aid to the students individually or collectively or in any other manner as the Board may deem fit.

(2) An application for a grant under these rules shall be made to the Board in Form-III annexed hereto and shall be submitted by the student (s) through the Head of the Institution in which he is studying.

(3) Individual grants from the fund shall be drawn by the person in whose favour grant is sanctioned on a simple receipt quoting therein the number and date of sanction.

8. Any other financial aid granted by the Government.
9. Amount applied for.
10. Reasons for the application with proof, if any.
