The Balochistan Government Employees Benevolent Fund(Amendment) Bill, 2021(Bill No.23 of 2021), having been passed by the Provincial Assembly of Balochistan on 13th September, 2021 and assented to by the Governor Balochistan, on 22nd September, 2021 is hereby published as an Act of the Balochistan Provincial Assembly.

The Balochistan Government Employees Benevolent Fund (Amendment), Act 2021, (Act No. XXIV of 2021).

ACT**

to further amend the Balochistan Government Employees Benevolent Fund Act. 2018 (Act No.XV of 2018)

Preamble. WHEREAS it is expedient further to amend the Balochistan Government Employees Benevolent Fund Act. 2018 (Act No.XV of 2018), in the manner hereinafter appearing:

It is hereby enacted as follows:-

Short title, and commencement 1. (1) This Act may be called The Balochistan Government Employees Benevolent Fund (Amendment) Act. 2021.

(2) It shall come into force at once and shall be deemed to have taken effect on and from 5th day of October, 2020.

Amendment in section 2, Act No.XV of 2018. 2. In the Balochistan Government Employees Benevolent Fund Act. 2018 (Act No.XV of 2018), hereinafter referred to as the "said Act" in section 2, in clause (c), the sign and the word "Jails", appearing after the word "Levies" shall be omitted.

Amendment in section 12, Act No.XV of 2018.

3. In the said Act, in Section 12;
- (a) in sub-section (1), after the word "retirement" the words "or declared invalid by the Medical Board" shall be inserted;
- (b) after sub-section (4), the following new sub-section shall be added:-
- "(5) the lump sum Benevolent Fund shall be paid to a dismissed, removed, terminated or compulsory retired employee proportion to the years he/she had served."

Omission of section 13 and 16, Act No.XV of 2018.

4. In the said Act, section 13 and 16 shall be omitted.

Amendment in section 20, Act No.XV of 2018.

5. In the said Act, in section 20, in sub-section (3) for the words/ expression "Provincial Employees Group Insurance Ordinance, 2007 (Ordinance No.XII of 2007", the words/expression" Balochistan Government Servants Benevolent Fund Ordinance, 1960 (Ordinance XIV of 1960) shall be substituted.
