## A BILL

further to amend the Balochistan Motor Vehicles Ordinance, 1965 (W.P Ordinance XIX of 1965).

Preamble.

Whereas it is expedient to amend the Balochistan Motor Vehicles Ordinance, 1965 (Ordinance No.XIX of 1965), in the matter hereinafter appearing;

It is hereby enacted as follows:-

Short title, and Commencement.

- 1. (1) This Act may be called the Balochistan Motor Vehicles (Amendment) Act, 2020.
  - (2) It shall come into force at once.

Substitution of the Twelfth Schedule, to W. P. Ordinance XIX of 1965. 2. In the Balochistan Motor Vehicles Ordinance, 1965 (W.P Ordinance XIX of 1965) for THE TWELFTH SCHEDUE the following shall be substituted, namely:-

- 2. The penalties are mentioned above not exceeding the approved fine rates applied in other cities of Pakistan.
- If traffic violators are not pinched with a reasonable amount of fine, they will never start respecting traffic laws.
- 4. Tinted glasses market cost is between Rs. 2500/-to Rs. 5000/-. A person who spends thousands of rupees on installation of tinted glasses he/she can also pay a meager amount of Rs. 500/- as fine easily. These lesser penalties encourage the criminal elements for repeatedly using the tinted glasses during their unwanted activities.

#### Statement of object and reasons.

#### a. Statement of object .

Evidence shows that the size of fines has an effect on violation behavior. Studies have shown that higher fines are associated with violations. Hundreds of traffic violations are witnessed in Quetta almost on daily basis, which cause slow traffic, blockage of roads, and disability / loss of precious lives in road accidents. Hence enhancement of penalty / fine can help restrain people from such violations. Western Countries, Middle East, Europe etc are the leading example where Traffic violations are minimal due to heavy fines.

#### b. Reasons for Penalty enhancement.

Traffic fines have been enhanced in Federal Capital Islamabad and Punjab Province, in recent past. In Balochistan these fines were lastly enhanced in the year, 2017, therefore, due to currency devaluation and strict enforcement of Traffic Laws in Quetta City, Traffic Fines are also required to be enhanced, please.
