to further amend the Balochistan Sea Fisheries Ordinance, 1971 (Ordinance IX of 1971).

Preamble.

Whereas, it is expedient to further amend the Balochistan Sea Fisheries Ordinance (Ordinance IX of 1971), in the manner hereinafter appearing;

It is hereby enacted as follows: -

**Short title and
Commencement.**

1. (1) This Act may be called the Balochistan Sea Fisheries (Amendment) Act, 2022.

(2) It shall come into force at once.

**Insertion of new
Section in
Ordinance IX
of 1971.**

2. (1) In the Balochistan Sea Fisheries Ordinance 1971, (Ordinance IX of 1971), after section 8, the following new section shall be inserted; namely: -

**Function of
Patrolling staff as
a Force.**

“8 A. The Fisheries Patrolling Staff will be a weapons carrying force for patrolling in the territorial waters and onshore too, for enforcement of provisions of Balochistan Sea Fisheries Ordinance, 1971”.
