No.PAB/Legis:V(19)/2022/8185. The Balochistan Shops and Establishments (Amendment) Bill, 2022 (Bill No.19 of 2022), having been passed by the Provincial Assembly of Balochistan on 26th April, 2022 and assented to by the Governor Balochistan, on 28th April, 2022 is hereby published as an Act of the Balochistan Provincial Assembly.

**The Balochistan Shops and Establishments (Amendment) Act, 2022,
Act No. XV 2022.**

**AN
ACT**

to amend the Balochistan Shops and Establishments Act, 2021 (Act No. XVII of 2021).

Preamble.

It is necessary to amend the Balochistan Shops and Establishments Act, 2021 (*Act No. XVII of 2021*) for the purpose to remove ambiguities, facilitate enforcement and to ensure effective implementation of the provisions regarding working conditions in the shops and establishments of the province; and, for other purposes.

It is hereby enacted as follows: --

Short title and commencement.

1. (1) This Act shall be called the Balochistan Shops and Establishments (Amendment) Act, 2022.

(2) It shall come into force at once.

Amendment section 28, Act No. XVII of 2021.

2. In Balochistan Shops and Establishments Act, 2021 (*Act No. XVII of 2021*), hereinafter referred to as "the said Act," in section 28; in the marginal heading of section 28, the words "*and fee for registration*" shall be omitted;

Amendment of Schedule, Act No. XVII of 2021.

3. In the said Act, in the "SCHEDULE";

(a) Under heading "SCHEDULE" for the figure "27" the figure "28" shall be substituted.

(b) In "FORM 'A'", the "Note" appearing at the end shall be omitted.


- (c) In "FORM 'B'", under heading "REGISTER OF ESTABLISHMENTS", for the figure "27" the figure "28" shall be substituted; and
- (d) In "FORM 'C'" for the heading "REGISTER OF ESTABLISHMENT "The heading "REGISTRATION CERTIFICATE" shall be substituted.


