An Ordinance to provide for the establishment of an Authority for the development and improvement of certain areas in Tehsil Hub, District Lasbela.

Preamble.

WHEREAS it is expedient to make provision for the development and improvement of certain areas in Tehsil Hub, District Lasbela, providing public amenities like Parks, gardens and tourist resorts;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEAREFORE, in exercise of the powers conferred by Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981, (C. M. L. A. Order No.1 of 1981), the Governor of <sup>2</sup>Balochistan in pleased to make and promulgated the following Ordinance:—

Short title, extent and commencemen t.

- 1. (1) This Ordinance may be called the Hub Dam Area Development Ordinance, 1984.
- (2) It extends to whole of Tehsil Hub, District Lasbela.
  - (3) It shall come into force at once.

Definitions.

- 2. In this Ordinance, unless there is anything repugnant in the subject or context:—
  - (a) "Authority" means an Authority constituted under section 3;
  - (b) "Committee" means Hub Lake Development Committee constituted by the Ministry of Tourism, Culture and Sports, Government of Pakistan;
  - (c) "Government" means Government of Balochistan;
  - (d) "Notified area" means the area comprising Hub Lake, Hub dam and the land within one mile radius of the lake, situated in the Province of

Republic of Pakistan, (1973).

Spelling of the word "Baluchistan", wherever it appears in this Ordinance, is corrected by insertion of letter "o" instead of "u", as per Government of Balochistan, S&GAD's Notification No. SORI (4) 6/ S&GAD-89, dated 18th June, 1989.

# Appointment of Authority.

3. The Government may, by notification, appoint any body corporate, local Council, Government functionary, organisation or committee to act as Authority for the notified area for the purposes of this Ordinance.

# Functions of Authority.

4. The Authority shall perform such functions and exercise such powers as may be specified by the Government from time to time for development of notified area for the purpose of providing public amenities and tourist resorts.

# Restriction on construction and development activity.

5. No person or body of persons shall construct any building or undertake development activity of any kind in notified area without prior written approval of the Authority.

## Penalty.

6. Whoever contravenes the provisions of section 5 or of any rules made under this Ordinance shall be punished with simple imprisonment for a term not exceeding six months or with fine, or both.

# Indemnity.

7. No suit or legal proceeding shall lie against Government or the Authority in respect of any thing done or intended to be done in good faith under this Ordinance.

# Power to make rules.

8. The Government may make rules for the purpose of giving effect to the provisions of this Ordinance.
