Preamble.	WHEREAS it is expedient to amend the Prisons Act,1894, in its application to the Province of ² West Pakistan for the purposes hereinafter appearing;
	It is hereby enacted as follows:-
Short title.	1. This Act may be called the Prisons ² (West Pakistan Amendment) Act, 1958.
Amendment of section 3, Act IX of 1894.	2. In section 3 of the ³ Prisons Act, 1894 (hereinafter called the principal Act), after clause (7) the following clause (7-A) shall be inserted—
	"(7-A) 'Deputy Inspector-General' means the Deputy Inspector-General of Prisons."
Amendment of section 5, Act IX of 1894.	3. Section 5 of the principal Act shall be numbered as sub- section (1) and thereafter the following new sub-section shall be inserted—
	"(2) Director of Prisons shall be appointed for the territories to be defined by the Provincial Government and shall exercise, subject to the orders of the Provincial Government and the ⁴ (Director of Prisons} such powers in respect of superintendence of prisons and the staff employed in the prisons in their respective territories as may be assigned to them by the Provincial Government."
Amendment of section 11, Act	4. In sub-section (2) of section 11 of the principal Act between the words "report" and "to" the words "through the
