An Act further to amend the Railways (Transport of Goods) Act. 1947.

Preamble.

WHEREAS it is expedient to amend the Railways (Transport of Goods) Act, 1947, in the manner hereinafter appearing;

It is hereby enacted as follows:—

Short title.

1. This Act may be called the Railways (Transport of Goods) (West Pakistan Amendment) Act, 1963.

Amendment of section 1 of Act XII of 1947. 2. In sub-section (3) of section 1 of the Railways (Transport of Goods) Act, 1947, hereinafter referred to as the said Act, for the word "sixteen", the word "eighteen" shall be substituted.

Amendment of section 2 of Act XII of 1947.

- 3. In section 2 of the said Act, for clause (c), the following shall be substituted, namely:—
 - "(c) 'railway administration' means the administration of the Pakistan Western Railway within the meaning of the Railways Act, 1890² (Act IX of 1890)."

4. In section 3 and section 6 of the said Act, for the words "Central Government", wherever occurring, the words "Principal Government" shall be, substituted.

5. In section 4 of the said Act, for the word "every", the word "the" shall be substituted.
