An Act further to amend the Societies Registration Act, 1860 (XXI of 1860). WHEREAS it is expedient further to amend the Societies Registration Act, 1860, in the manner hereinafter appearing; It is hereby enacted as follows: —

commencemen1.(1)This Act may be called The Societies Registration(Balochistan Amendment) Act, 1997.

Insertion of new
Section after2.In the Societies Registration Act, 1860, in its application
to the Province of Balochistan, hereinafter referred to as the said
Act, after section 4, the following new section shall be inserted,
namely: —

1860. "4 A. <u>Audit Report</u>. Once in every year on close of financial year and Audit Report by Accountants as defined in Income Tax Act, shall be provided by the Governing Body duly signed and approved to the Registrar of Societies. It shall be mandatory to keep Books of account interring therein income from all sources and expenditure incurred by the Society. The Registrar of Societies may examine the entries in the Book of account as and when needed".

Insertion of new
Section after3.In the said Act, after section 5, the following new section
shall be inserted, namely: —

Section 5, of
Act XXI of
1860."5 A. Member of Society shall not avail financial
benefit. All Non Government Organizations and
Societies registered under this Act, shall work to achieve
the objectives on non-commercial basis. Any member of
the society shall not avail financial benefits from

> Charitable Societies. Societies established for the promotion of Science, Literature or the fine arts, for instruction, the diffusion of useful knowledge, (the diffusion of political education), the foundation or maintenance of Libraries or reading-rooms for general use among the members or open to the public, or public museums and galleries of painting and other works of art, collections of natural history, mechanical and philosophical inventions, instruments or designs, Management, overseeing, monitoring and providing Supervisory cover to local institutions such as Primary Schools, Middle Schools, High Schools, Dispensaries, Basic Health Units and Rural Health Centers and other Health Institution, Population Welfare facilities, Water Supply and Sanitation facilities".
