It is hereby enacted as follows: -

Short title and commencement.

- This Act may be called the Balochistan Public Finance Management (Amendment) Act, 2023.
 - (2) It shall come into force at once.

Amendment in Section 16 of the Balochistan Public Finance Management Act, 2020 2. in the Balochistan Public Finance Management Act, 2020, in section 16, in subsection (1), for the word "two" the word "three" shall be substituted.
