to further amend the Balochistan Public Finance Management Act, 2020 enacted through Balochistan Finance Act, 2020 (Act No. I of 2020).

**Preamble.** **WHEREAS,** it is expedient to further amend the Balochistan Public Finance Management Act, 2020 enacted through Balochistan Finance Act, 2020 (Act No. I of 2020) for the purposes hereinafter appearing;

It is hereby enacted as follows: -

**Short title and commencement.**

1. 1) This Act may be called the Balochistan Public Finance Management (Amendment) Act, 2023.

(2) It shall come into force at once.


**Amendment in Section 16 of the Balochistan Public Finance Management Act, 2020**

2. in the Balochistan Public Finance Management Act, 2020, in section 16, in sub-section (1), for the word "two" the word "three" shall be substituted.


