No. SOR-II (16)1/2017-S&GAD/1857-78 . In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Advocate General's Establishment (BPS-16 and above) Service Rules, 2017 (Service Rules No. XI of 2017), namely:-

(a) Bachelor's Degree in Law (LL.B) at least in Second Division from a recognized University; and (b) three (3) years' experience as Prosecuting Inspector or three (3) years' as a practicing Lawyer.	(a) 50% by promotion from amongst the members of the Services holding the post of Superintendent (BPS-17) having at least three (3) years' Service as such, on seniority cum fitness basis; with fourteen years' educational qualification. The fourteen years' educational qualification is relaxed on attaining the age of 55 years; and (b) 50% by initial recruitment.
7.	Executive Officer Judicial, (BPS-17).	(a) Bachelor's Degree in Law (LL.B) at least in Second Division from a recognized University; and (b) Three (3) years' experience as Prosecuting Inspector or three (3) years' as a practicing Lawyer.	(a) 50% by promotion from amongst the members of the Services holding the post of Superintendent (BPS-17) having LL.B Degree from a recognized University with at least three (3) years' Service as such, on seniority cum fitness basis. If no suitable candidate is available for promotion the post shall

(a) 50% by promotion from amongst the members of the Services holding the post of Assistant Accounts Officer (BPS-16) having at least three (3) years' Service as such, on seniority cum fitness basis; and (b) 50% by initial recruitment.

The fourteen years educational qualification is relaxed on attaining the age of 55 years.
11.	Translator, (BPS-17).	---	By promotion from amongst the members of the Service holding the posts of Assistant Translator (BPS-14) having Degree in Law from a recognized University with at least five (5) years' service as such, on seniority cum fitness basis.

Data Base Administrator, (BPS-17).	---	By promotion from amongst the members of the Service holding the posts of Computer Operator (BPS-16) having at least three (3) years' service as such, on seniority cum fitness basis with fourteen years' educational qualification in relevant technology. The fourteen years educational qualification is relaxed on attaining the age of 55 years.
13.	Private Secretary, (BPS-17).	---	By promotion from amongst the members of the Service holding the post of Assistant Private Secretary (BPS-16) having at least three (3) years' Service as such, on seniority cum fitness basis with fourteen years' educational qualification. The fourteen years educational qualification is relaxed on attaining the age of 55 years.
14.	Superintendent, (BPS-17).	---	By promotion from amongst the members of the Service holding the post of Assistant (BPS-16) having at least three (3) years' Service as such, on seniority cum fitness basis with fourteen years' educational qualification. The fourteen years educational qualification is relaxed on attaining the age of 55 years.
15.	Assistant Accounts Officer, (BPS-16).	---	By promotion from amongst the members of the Service holding the post of Accounts Assistant (BPS-14) having at least three (3) years' Service as such, on seniority cum fitness basis.
16.	Assistant Private Secretary, (BPS-16).	---	By promotion from amongst the members of the Service holding the post of Stenographer (BPS-14) having at least three (3) years' Service as such, on seniority cum fitness basis with fourteen years' educational qualification. The fourteen years educational qualification is relaxed on attaining the age of 55 years.

17	Computer Operator, (BPS-16).	Bachelor's Degree at least in Second Division in Computer Science or in IT or equivalent qualification in the relevant subject from a recognized University.	(a) 75% by promotion from amongst the members of the Services holding the post of Assistant Computer Operator (BPS-12) having at least three (3) years' Service as such, on seniority cum fitness basis with fourteen years' educational qualification in relevant technology. The fourteen years educational qualification is relaxed on attaining the age of 55 years; and (b) 25% by initial recruitment.
18.	Assistant, (BPS-16).	(a) Bachelor's Degree from a recognized University; and (b) having at least three months Office Automation Certificate in computer operations from a recognized Institute.	(a) 70% by promotion from amongst the members of the Service holding the post of Senior Clerk (BPS-14) having at least three (3) years' service as such, on seniority cum fitness basis with fourteen years' educational qualification. The fourteen years educational qualification is relaxed on attaining the age of 55 years; and (b) 30% by initial recruitment.
