## NOTIFICATION

No.SOR-II (8)27/2016-S&GAD/ 2368-85. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Health Department (Post Graduate Medical Institute) (BPS-16 and above) Service Rules, 2016 (Service Rules No. XXXII Of 2016), namely:-

In the aforesaid rules, in appendix the existing serial numbers 1,2, 2-A, 2-B, 2-C, 2-D, 3,4,6,7,8 and 9 shall be re-numbered as serial numbers 4,5,6,7,8,9,10, 11,12,13,14,15,16 and thereafter at S.No.1,2 and 3, the following new entries shall be inserted.

1.	Senior Librarian (BPS-18)	---	By promotion from amongst the members of the Service holding the post of Librarian (BPS-17) possessing Bachelor in Library and Information Science or equivalent qualification with at least five (5) years' service, on seniority cum fitness basis.
2.	System Analyst (BPS-18)	---	By promotion on combined seniority from amongst the members of the Service holding the post of Computer Programmer Technical (BPS-17) and I.T Officer Technical (BPS-17) possessing MBA-IT/ MCS / M.SC. Computer science or BCS (4 years) from recognized university with at least five (5) years' service, on seniority cum fitness basis.
3.	Senior Audio Visual Operator (BPS-17)	---	By promotion from amongst the members of the Service holding the post of Audio Visual Operator Technical (BPS-16) with at least three (3) years' service as such, on seniority cum fitness basis; and having Bachelor's Degree or Master's Degree or equivalent. The condition of Bachelor's Degree or 16 years of education is relaxed on attaining the age of 55 years'.
