S.O (R-II)(8)19/2015-S&GAD/137-86 In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Health Management Cadre (Basic Pay Scale 17 and above) Service Rules, 2001, namely:-

In the aforesaid rules, in Appendix, under heading HMC/BPS-20 (Doctors), for serial No.7 the following shall be substituted, namely,-

- "7. (a) Director General (Health Services), (BPS-20); --- By promotion from amongst the members of the Service holding the posts of HMC/BPS-19 Doctors Provincial Coordinator (BPS-19), Medical Superintendent, 50-Bedded Hospitals (BPS-19), Deputy Medical Superintendent Tertiary Care Hospitals (BPS-19), Additional Director (BPS-19), Principal Multipurpose and Paramedics Training School (BPS-19), Executive District Officer Health (BPS-19), Director Health Services/Public Health (BPS-19), Director HRD (BPS-19), Director, Logistics (BPS-19) and Principal, Public Health School (BPS-19) having at least seventeen (17) years service in BPS-17 and above or twelve (12) years service in BPS-18 and above, on seniority cum fitness basis; and have successfully completed Senior Management Course (SMC)."
- (b) Medical Superintendent Tertiary Care Hospitals, (BPS-20);
- (c) Divisional Director (Health Services), (BPS-20); and
- (d) Executive Director, Sheikh Khalifa Bin Zaid Hospital, (BPS-20).
