S.O (R-II)(8)19/2015-S&GAD/2496-2545 In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Health Management Cadre (Basic Pay Scale 17 and above) Service Rules, 2001, namely,-

In the aforesaid rules,-

- (a) in rule 2, clause (k) shall be omitted; and
- (b) in Appendix, under heading HMC/BPS-18 (Doctors) and HMC/BPS-19 (Doctors), for Serial Nos. 3 & 5, the following shall be substituted, namely,-
