NOTIFICATION

No.S.O(R-II)(10)14/2020-S&GAD/2701-50. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Industries and Commerce Department (BPS-16 and above) Service Rules, 2016 (Service Rules No. XLIII of 2016), namely:

In the aforesaid rules, in Appendix, against Serial No. 5, 11 & 22, for the existing entries, the following shall be substituted, namely,-

5.	Executive Engineer, (BPS-18).	---	(a) By promotion from amongst the members of the Service holding the post of Sub Divisional Officer (BPS-17) (Civil, Mechanical & Electrical) Degree in the relevant field from a recognized University and having at least five (5) years' service as such, on seniority cum fitness basis; and (b) registered with Pakistan Engineering Council; and (c) have successfully completed 8 weeks mandatory In-Service Training Course from the Government Engineering Academy Punjab at Lahore or any other Government Engineering Academy.
11.	Sub Divisional Officer, (BPS-17).	(a) Bachelor's Degree at least in Second Division in the relevant Technologies i.e. in Civil, Mechanical or Electrical Engineering from a recognized University; and (b) having registration as Engineer with Pakistan Engineering Council.	(a) 25% by promotion from amongst the members of the Service holding the post of Junior Engineer (BPS-16) Civil, Mechanical and Electrical Diploma of Associate Engineering in the relevant field from a recognized Institute and having at

least five (5) years' service as such, on seniority cum fitness basis;

Provided that no professional engineering works shall be assigned;

(b) 25% by promotion from amongst the members of the Service holding the post of Sub Engineer (BPS-11) Civil and Electrical with Bachelors' of Engineering Degree in the relevant field from a recognized University and having at least five (5) years' service as such, on seniority cum fitness basis;

(c) 25% by promotion from amongst the members of the Service holding the post of Sub Engineer (BPS-11) Civil and Electrical with Bachelors' of Engineering Degree in the relevant field from a recognized University, during the service with at least five (5) years' service as such, on seniority cum fitness basis; and

(d) 25% by initial recruitment;



have undergone 16 weeks mandatory Pre-Service Training Course from the Government Engineering Academy Punjab at Lahore or any other Government Engineering Academy for New Entrants (Freshly Appointed Engineers) as and when appointments are made and nominations received.

Junior Engineer, (BPS-16).	---	By promotion from amongst the members of the Service holding the post of Sub Engineer (BPS-11) (Civil, Mechanical & Electrical) Diploma of Associate Engineering in the relevant field from a recognized Institute and having at least five (5) years' service as such, on seniority cum fitness basis.
