NOTIFICATION

No.SOR-II(10)14/2020-S&GAD/ 2751-2800. In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Industries and Commerce Department (BPS-16 and above) Service Rules, 2016 (Service Rules No. XLIII of 2016), namely:-




In the aforesaid rules, in Appendix

- (a) against Serial No. 2 and 6, for the existing entries, the following shall be substituted, namely,-

2.	(a) Director, (BPS-19); and (b) Director (Estate and Development), (BPS-19).	---	By promotion from amongst the members of the Service holding the post of Deputy Director (BPS-18) having at least twelve (12) years' service in BPS-17 and above or seven (7) years' service as such, on seniority cum fitness basis; and have successfully completed Mid Career Management Course (MCMC).
6.	Assistant Director, (BPS-17).	(a) Master's Degree at least in Second Division in Economics or Commerce (M.Com) or Business Administration (MBA) from a recognized University; or (b) Bachelor's Degree in Industrial Engineering from a recognized University; and (c) having registration with Pakistan Engineering Council.	(a) 40% by promotion from amongst the members of the Service holding the post of Superintendent (BPS-17) having at least three (3) years' service as such, on seniority cum fitness basis; (b) 10% by promotion from amongst the members of the Service holding the post of Registration Officer (BPS-16) having at least three (3) years' service as such, on seniority cum fitness basis; and (c) 50% by initial recruitment.

(b) after Serial No. 15, the following new entries shall be inserted, namely,-

15-A.	Private Secretary, (BPS-17).	---	By promotion from amongst the members of the Service holding the post of Assistant Private Secretary (BPS-16) having at least three (3) years' service as such, on seniority cum fitness basis.
15-B	Recovery Officer, (BPS-17).	Master's Degree at least in Second Division in Commerce (M.Com) or equivalent qualification from a recognized University 	(a) 50% by promotion from amongst the members of the Subordinate Service holding the post of Inspector Recovery (BPS-15) having at least eight (8) years' service as such, on seniority cum fitness basis; and (b) 50% by initial recruitment.
15-C.	Khateeb, (BPS-16).	(a) Al Shahdat-ul-Aalmia (Equivalent to Master's Degree) from Wafaq-ul-Madaris, Tanzeem-ul-Madaris or from any of the HEC recognized Institution; (b) having good command of Arabic language and have more than average proficiency in Quran and Hadith; and (c) Hafiz-ul-Quran and Qari will be preferred.	(a) 50% by promotion from amongst the members of the Subordinate Service holding the post of Pesh Imam (BPS-14) possessing Al Shahdat-ul-Aalmia (Equivalent to Master's Degree) from Wafaq-ul-Madaris, Tanzeem-ul-Madaris or from any of the HEC recognized Institution with at least three (3) years' service as such, on seniority cum fitness basis; and (b) 50% by initial recruitment.
