**NOTIFICATION**

[27<sup>th</sup> January, 1977]

No. SOI (H) 3-7/75. In exercise of the powers conferred by Section 6 of the Balochistan Charge Nurses (Compulsory Service) Act, 1975<sup>3</sup> (Act No. XI of 1975), the Government of Balochistan is pleased to make the following rules, namely: —

1. **Short title, commencement and application.** — (i) These rules may be called "the Balochistan Charge Nurses (Compulsory Service) Rules, 1976".  
(ii) They shall come into force at once, and shall apply to all Charge Nurses wherever they may be.
2. **Definitions.** — (1) In these rules, unless the context otherwise requires: —
  - (i) "**Act**" means the Balochistan Charge Nurses (Compulsory Service) Act, 1975<sup>3</sup>.
  - (ii) "**Government**" means the Government of Balochistan.
  - (iii) "**Charge Nurses**" means as defined in the Act.
  - (iv) "**Notice**" means notice issued in pursuance of S. 3 of the Act.
3. **Notice.** — A notice requisitioning the service of a Charge Nurses shall be in the form as in the schedule appended to these rules and shall be issued by Government.
4. **Time Limit.** — The person whose services are requisitioned under this Act shall report for duty to the Secretary Health Department within fifteen days of the receipt of the notice. On her failure she shall be liable to persecution under Section 4 and 5 of the Act.

### **NOTICE**

#### **NOTICE FOR COMPULSORY SERVICE UNDER THE BALOCHISTAN CHARGE NURSES (COMPULSORY SERVICE) ACT, 1975.**

Whereas you \_\_\_\_\_, Charge Nurse has qualified the Charge Nurses Examination conducted by the West Pakistan Nursing Service Council Lahore/Punjab Nursing Service Council Lahore, Nursing Examination Board, Balochistan Quetta at the expenses and quota of the Government of Balochistan against the reserved seats of former Quetta and Kalat Division after the 1<sup>st</sup> day of July, 1970 and thus become liable to serve the Province of Balochistan at least 3 years;

And whereas your services are required by the Government of Balochistan under Section 3 of the Balochistan Charge Nurses (Compulsory Service) Act, 1975 you are hereby, called upon to report for duty to the Secretary to Government of Balochistan, Health Department, within 15 days of the receipt of this notice, failing which action will be taken against you under Section 4 & 5 of the said Act.
