NOTIFICATION

[27th January, 1977]

No. SOI (H) 3-7/75. In exercise of the powers conferred by Section 6 of the Balochistan Charge Nurses (Compulsory Service) Act, 1975³ (Act No. XI of 1975), the Government of Balochistan is pleased to make the following rules, namely:—

- 1. **Short title, commencement and application.** (i) These rules may be called "the Balochistan Charge Nurses (Compulsory Service) Rules, 1976".
- (ii) They shall come into force at once, and shall apply to all Charge Nurses wherever they may be.
- 2. **<u>Definitions.</u>** (1) In these rules, unless the context otherwise requires:
 - (i) "**Act**" means the Balochistan Charge Nurses (Compulsory Service) Act, 1975³.
 - (ii) "Government" means the Government of Balochistan.
 - (iii) "Charge Nurses" means as defined in the Act.
 - (iv) "Notice" means notice issued in pursuance of S. 3 of the Act.
- 3. **Notice.** A notice requisitioning the service of a Charge Nurses shall be in the form as in the schedule appended to these rules and shall be issued by Government.
- 4. <u>Time Limit.</u>—The person whose services are requisitioned under this Act shall report for duty to the Secretary Health Department within fifteen days of the receipt of the notice. On her failure she shall be liable to persecution under Section 4 and 5 of the Act.

These rules have been issued by the Health and Social Welfare Department, Government of Balochistan, vide its Notification No. SOI (H)3-7/75, dated 27th January, 1977; and published in the Balochistan Gazette (Extraordinary) No. 4, dated 27th January, 1977
