In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Labour Welfare Department (BPS-16 and above) Service Rules, 2018 (Service Rules No. XVII of 2018), namely:-

(a) after S.No. 3, the following new entry shall be inserted, namely;-

3-A.	Administrative Officer, (BPS-17) Weights and Measures.	---	By promotion from amongst the members of the Service holding the post of Superintendent (BPS-17) Weights and Measures having at least three (3) years' service as such, on seniority cum fitness basis; and possessing Graduation qualification or qualification equivalent to Graduation. The condition of Graduation/ equivalent qualification for promotion is relaxed on attaining the age of 55 years.

Assistant Private Secretary, (BPS-16) Weights and Measures.	---	By promotion from amongst the members of the Service holding the post of Stenographer (BPS-14) Weights and Measures having at least three (3) years' service as such, on seniority cum fitness basis; and possessing Graduation qualification or qualification equivalent to Graduation. The condition of Graduation/ equivalent qualification for promotion is relaxed on attaining the age of 55 years.

Assistant Accounts Officer, (BPS-16) Weights and Measures.	---	By promotion from amongst the members of the Service holding the post of Accountant (BPS-14) Weights and Measures having at least three (3) years' service as such, on seniority cum fitness basis; and possessing B.Com or BBA. The condition of B.Com or BBA for promotion is relaxed on attaining the age of 55 years.
